NHSBS Receives First HOME Grant Award through the New York State Housing Trust Fund Corporation's, Office of Community Renewal

Neighborhood Housing Services of Bedford-Stuyvesant, Inc. (NHSBS) was among a state-wide list of organizations announced last week, including NHS of East Flatbush and NHS of Northern Queens, that was awarded funding through the Office of Community Renewal (OCR) to provide affordable housing opportunities for New Yorkers. NHSBS was awarded \$400,000.00 to assist first-time home buyers with down-payment and closing cost assistance in the purchase of their first home. In this funding round, the OCR will award over \$17 million dollars in NYS HOME Local Program funds to assist communities all across New York State in addressing their affordable housing needs. Working collaborative with local partners, these investments will help to revitalize residential housing and help improve the quality of life across communities. NHSBS Congratulates First Affordable Housing Corporation (AHC) Grantee

First-time homebuyer, Crystal Wallace, standing in front of her new home with her son, was the first recipient of an AHC 'conditional' grant award made possible through the Affordable Housing Corporation (AHC) of the New York State Homes and Community Renewal (HCR). Ms. Wallace was selected through the lottery process and received \$27,000.00 toward the acquisition and rehabilitation of her first home. Crystal, the mother of a 9-year old son, was able to close on a beautiful one-family home in Canarsie at the end of February. An administrator for the New York City Human Resources Administration, she was able to buy a stake in the city she's worked in for more than 20 years with an affordable mortgage of \$350,000.00 with a 4% interest rate. The AHC program mandates the 'meaningful' participation of Minority and Women owned Business Enterprises (WMBE) in the development of all projects. Ms. Wallace was able to utilize \$13,777.50 of the grant funds toward a full renovation of her bathroom and replacement of doors and windows throughout her home and \$13, 222.50 toward down-payment and closing cost. This was a milestone in Crystal's life and she says she is very eager to move in, meet her neighbors and get involved in her new community.

For first-time homebuyers to assist with the Acquisition and Rehabilitation of your first home; Conditional grants up to \$27,000 each. A required Minimum of 51% of the grant must be used toward the rehabilitation of the property and the remaining toward down-payment and closing cost assistance

NHS foreclosure counselors were on hand to provide personal consultations to homeowners in need of mortgage assistance. The Foreclosure Workshop was held on Wednesday, March 30th from 6:00 pm to 8:00pm at Hofstra University, Hempstead New York, in the college's spacious Multi-purpose room at the Student Center. The event was hosted by the offices of U.S. Senator Kirsten Gillibrand and New York State Attorney General Eric Schneiderman. Also on hand for the evening were representatives from the U.S. Department of Housing and Urban Development and the Consumer Financial Protection Bureau. Also on hand for the evening, providing free personal consultation were other HUD approved agencies; Long Island Community Development Corporation, Long Island Housing Partnership, Debt Counseling Corporation (DCC) and Safeguard Credit Counseling Services Inc. Dina Levy from the Office of the Attorney General addressed the audience and provided an overview of fraudulent practices, foreclosure prevention and solutions.

Project HELP



Neighborhood Housing Services of New York City, Inc. (NHSNYC) will administer a

Home Emergency Loan Program (HELP) totaling \$2 million through June 30, 2016 to homeowners who are in need of emergency repairs in their home. The new program is funded through Initiative Funds from the New York City Council. The New York City Department of Housing Preservation (HPD) will provide oversight of the program. Project HELP will assist low and moderate income owners of one- to four-family homes or condominiums across the five boroughs, who are at or below 120% of Area Median Income, to address hazardous and/or emergency conditions within their home. The program will provide 'conditional' loans up to \$20,000.00 each, to qualified applicants

Eligible applicants must: own a 1-4 family home or condominium, occupy the property for at least two years, be a resident of NYC, meet household size and income requirements, be current on ALL property and water bills and have homeowner's insurance. A significant portion of the grant will be reserved for seniors, 60 years and above, with preference to seniors with disabilities and/or who are handicapped.



FREE Tax Preparation at NHSBS



NHSBS is hosting free VITA tax preparation sessions in partnership with GrowBrooklyn, a non-profit organization and affiliate of Brooklyn Cooperative Federal Credit Union, led by IRS-certified VITA/TCE preparers. The sessions are held in the NHSBS office on Tuesdays from 10am to 2pm through April 12th. The last day to submit 2015 tax returns is April 18th.

In order for your tax return to be processed properly, you must bring the following items:

- -Government-issued photo ID
- -Social Security (or ITIN) cards for yourself and all individuals on your return.
- -All W-2 forms, 1099-R, etc.
- -Documentation of higher education expenses, including tuition paid, loans received, student loan interest payments, and student fees.
- -All 1095 forms (ACA Proof of Coverage)
- -Child care expenses, provider information and tax ID number.
- -Bank account number/routing (ABA) number for direct deposit.
